KEY RISK

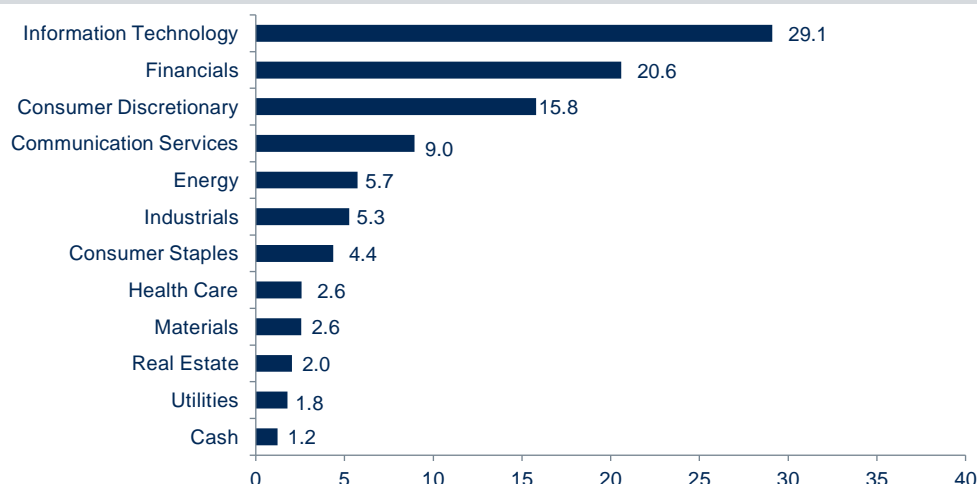
